Honoring Gary Delforge, EdD

ABOUT THE ENDOWMENT: This endowed scholarship was made possible through the generous donations of former students, colleagues, and friends who wanted to thank Dr. Delforge for the impact he made on the athletic training profession and in their lives. Many described him not just as a gifted teacher, but as a "surrogate father figure." RMATA (Rocky Mountain Athletic Trainers Association) established a scholarship endowment honoring Gary Delforge in 2012, and it annually awards an RMATA (D7) athletic training student with a \$2,300 scholarship. Prior to the endowment being established, the "Friends of Gary Delforge" Scholarship was awarded to students enrolled in various athletic training programs from 2003-2011.

ABOUT GARY DELFORGE: Gary Delforge, known as "Dr. D" to many, was a pioneer in his field and instrumental in helping Athletic Training become a certified profession. He began his pursuit of Health, Physical Education and Recreation at Kansas State University, where he earned his Bachelor of Science degree in 1960. He continued on to receive his Master of Science in this area, with a minor in secondary education from Kent State University, while working as a Graduate Assistant Athletic Trainer. Gary then took a position as an Assistant Athletic Trainer at Western Michigan University before taking the Head Athletic Trainer position at the University of Arizona in 1963. In 1973 he successfully completed his Doctorate of Education at the University of Arizona with a focus in Rehabilitation Administration and a minor in Education Administration. While working at the University of Arizona, he developed an accredited Graduate Athletic Training Education Program and worked as an Associate Professor until 1995. From 1995 to 2000, Gary served as Professor and Chair of the Department of Sport Medicine at A.T. Still University where he developed a Master of Science degree program in sports health care and a Graduate AT Education Program.

Sadly, Gary passed away May 19, 2023. While he had many achievements in his career, more important to Gary were his students and colleagues. He simply loved teaching and his greatest legacy will be his students, which, as of 2023, include:
